**UPDATE LOCAL LAW #4-PROPOSING NEW SECTION RE:

The Mayor stated the next item on the agenda: Update Local Law #4-Proposing a New Section for Basketball Hoops/Position in the Right of Way: We have looked at Local Law #4 Proposing a New Section for Basketball Hoops in the Right of Way, there has not been much progress. He spoke of riding down Herman and in 1 block there were 3 that looked like they planned on keeping them there for a while that were hanging out past the pavement; that is something that we should not have. He added we need to talk about this further and make a decision, because it is going to be basketball season really soon, especially when the kids are out of school. He explained he is all for making some kind of motion, but the penalty we had the 1st time maybe a little severe, so maybe we need to rework it. Mr. Ken Ryan stated you cannot expect people to pull them back, after nobody else did. The Mayor continued next meeting we should be ready to vote on something, if we need to make changes, we will make changes.

Fire Department: (Asst. Chief John Linnertz): He stated the following:

- Squad finishing up repairs, going to Albany to do an inspection
- Busy, (2) structure alarms: Fay Park, Hamilton, both started around garage; not intentional, but fueled with gasoline from presence of it; Vol. Members did great job, some injured

Public Works Department: (DPW Sup't.: Ed Ware): He stated the following:

- Working on Storm drain up by Chestnut where water ponds, to alleviate that problem
- Won Work Zone Safety Package from Cornell University, which includes flags, stands, and safety equipment, to help keep guys safe when working in roadway

Parks and Recreation Department: (Parks Director: Anthony Burkinshaw): He stated the following:

- Thursday, 6/1/23: Pool Passes will start, Vlg. residents will still get free Pool Passes with proof of residency, we will charge for swim lessons for residents and non-residents, due to increase in lifeguards and chlorine. \$30 Residents, \$55 for Non-Residents, Family pass \$125 will include 2 wks. of Swim Lessons: 1 session
- June 7th: Concert series starts

Codes Department: (Codes Enforcement Officer: Brandy Fry): She stated the following:

- Pearl, enjoy your vacation
- Family Fest: Will be there, stop if you question
- A lot of violation for vegetation, means Overgrowth maximum allowed 10"
- There is No Mow May, suggested mowing lawn to keep down the pests, pollinators will have to follow the regulation behind it
- Screening, includes planting trees, needs to be 10' back from property line in front yard
- Mr. Hummel asked about 10' x 10' shed, letter went out and email sent to Board 100 sq. ft. does require permit, Vlg. of N. Syracuse Code is more restrictive

Trustee Strong: He stated the following:

- Facebook comment: More info on Stop Work Order issued at 444 S. Main St., eyesore 2 yrs.
- 10' x 10' shed, difficulty hearing Code Enf. Officer Fry, Vlg. has adopted a more restrictive Code in past requiring permit, than NYS Code which cannot go less than
- Note participated in No Mow May, neighbor's probably thought looked trashy, but do get apples every yr., if we wanted to participate in No Mow May we would have to make that a local law to take part in that type of process where you could allow it for "x" period of time to allow the now mow for the pollinators, etc.
- Codes: Partnering towns discussing allowing Chickens, although nightmare, with cost of eggs at \$8 and \$9 per/dozen; less waste than medium size dog, less noise; so big push for substance living and prepare for themselves, so probably will come to Vlg., so should start
